#### **New CPT codes in WSH**

The CPT codes (99379, 99374, 99421, 99091, 93792, 99377) for WSH have been added with the exception of COVID testing. 87426 and G2023 for COVID specimen collection. Please bill all of the others services and add the COVID CPTs to a query. I am clarifying with the provider to see if the COVID testing is billable which I doubt.

The provider clarified related to the COVID Testing. Ends up it was provided to the patient but she didn't perform anything that is actually billable related to the specimen collection or the testing. She says to disregard the COVID testing. Please mark those queries as completed or disregard the COVID testing or specimen collection for WSH. If it comes through in the future please query it though so we can remind her about it.

## **Long Term care client Update**

Just a reminder that for any long term care clients (BAS, ADM, KTK, ELY and WSH), when we do not get insurance information with demographics. Please post the charge and suppress claim. Send query to biller so they can contact he facility for clarification. Long term care patients are rarely self pay.

This instruction has been added to all the long term care clients' instruction:

Self Pay: It is very rare for a Long Term Care patient to be Self Pay. If you get a Self Pay at registration - Question it. Check MMIS for any Medicaid coverage. If none, query biller so they can contact the patient. Okay to post the charge and suppress. Do not bill the patient until query is responded to.

#### Covid test billing (U0001)

CPT U0001 — we have been instructed by the provider to ignore this CPT. Okay to post all other CPT's.

#### CPT 87426 Update

Per provider (Shirley Hanley), we are to not post the code 87426. Please post all other codes


If CPT 99442 (Telephone evaluation and management service by a physician or other qualified health care professional who may report evaluation and management services provided to an established patient, parent, or guardian not originating from a related E/M service provided within the previous 7 days nor leading to an E/M service or procedure within the next 24 hours or soonest available appointment; 11-20 minutes of medical discussion) given in superbill, please use 99422 (Online digital evaluation and management service, for an established patient, for up to 7 days, cumulative time during the 7 days; 11-20 minutes).

#### **New format Superbill**

Client WSH is now using an EHR system called GEHRIMED to capture charges. For now they will come to us and we will upload them to eBridge for Processing.

- There is now an Encounter ID which will need to be entered as the Ticket Number.
- Also if it is a new patient please use the GEHRIMED patient account ID if a patient needs to be registered.

### **GEHRIMED**

We have some updates for WSH. They are now using an EHR called GEHRIMED. The practice is capturing charges and also they are loading demographics and saving a PDF of the patients demographics into the system. For this client registration will need to be found in this new software system to cross register into Healthpac and we will need to begin using the GEHRIMED Account Numbers and also using the GEHRIMED Encounter Number as the Ticket. I am working with the vendor for an interface but it will be a while before this is able to go live.

## **GEHRIMED**

Effective 04/01/2022 client started using GEHRIMED EHR

You Must Download the client Installer: <a href="https://download.gehrimed.com/">https://download.gehrimed.com/</a>

Then login and a text message will be sent to confirm access. This is set to go to 541.665.4420 and can be retrieved via Zulu.

Once Installed you will need to login an receive a text message. You can then access Demographics from GEHRIMED to cross register.

You can find patients in GEHRIMED and access an image of their face sheet which has been uploaded by the client.

Please use the GEHRIMED Account number for the patient and also use the Encounter Number as the Ticket Number

#### Also for coding items -

DX -R62.51 (failure to thrive child) is ok to change to R62.7 (failure to thrive adult) per Shirley.

For Smoking Counseling 99406 it is OK to add the DX code as Z87891

Please download and install the GEHRIMED client program and then use the following login to access demographics:

Also please work the Charge Queries that are in need of demographics to take the next steps to register patients and post charges for prior items in need of demographics. I also uploaded a large batch of charges – you will need access to GEHRIMED to access demographics before you can post the charges. Please let me know if you have any trouble accessing demographics in this new system.

#### **GEHRIMED CLARIFICATIONS W/ RESPONSES**

a) Is there any restriction time or cut-off time that we do not access this GEHRIMED system?

I am not aware of a time restriction. Can you please test again and see if you have the same results?

b) We are able to find the patient demographics from GEHRIMED system from the new format WSH Superbills using Encounter ID. However, using DOB/name search for previous WSH format super bills (Pending queries) does not find patient's face sheet in GEHRIMED system. Please advise, shall we search new format superbill pending queries only and wait for MMSS response for old format WSH pending queries [Patient not found in Hpac]?

Yes - it would be the new format charges only that have demographics in GEHRIMED. This practice does see patients multiple times though so it is possible that a patient previously in need of denis would now have it in GEHRIMED if they gave a new encounter.

c) Do we need to use **GEHRIMED Patient ID** for all WSH patients effective from now on (or) Only for new patients? Since we are not yet moved to GEHRIMED Interface process.

Let's just do new patients for now with GEEHRIMED ids. If the patient is already registered it is fine to use their prior account.
